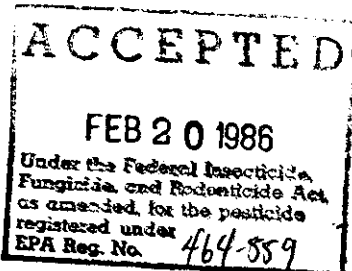

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Call a physician or Poison Control Center immediately. Do not induce vomiting. Contains an aromatic petroleum solvent. Do not give anything by mouth to an unconscious person. **If On Skin:** Immediately wash with plenty of soap and water. Get medical attention. **If In Eyes:** Flush with plenty of water for 15 minutes. Get medical attention. **If Inhaled:** Remove to fresh air if symptoms of cholinesterase inhibition appear and get medical attention immediately.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate significance of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as 2-PAM/protopam, may be therapeutic if used early; however, use only in conjunction with

atropine. In case of severe acute poisoning, use antidote immediately after establishing an open airway and respiration.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

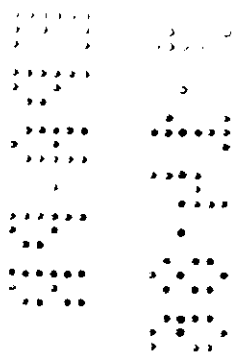
