General Information: Use Dursban WB05 insecticide to control the pests indicated in the areas listed below by application of the product as an unciluted spray (0.5% chlorpyrifos). Repeat the treatment as needed.

Do not apply sprays of this product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. Do not use in poultry houses other animal buildings. Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying.
