Your Resubmission Dated June 3, 1998

The labeling referred to above, submitted in accordance with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended is acceptable with the following provisions:

1. Under the "First Aid" section of the labeling, in the dermal statement, revise the scnd second sentence so that it reads: "Get medical attention."
2. In the area of the labeling addressing the use sites, "peas and clover" are listed as one of the sites. As you are aware, IR-4 is supporting MCPA DMAS for use in the Pacific Northwest only. Therefore, amend the label to reflect that "peas and clover" " are for use in the Pacific Northwest only."

It is noted that in your original submission (dated May 11, 1998) you selected to delete the unsupported use (rice) from your product label. Once the use deletion process is completed, a letter will be forwarded acknowledging this action.

A stamped copy is enclosed for your records. Please submit one (1) final printed copy for the above mentioned label before releasing the product for shipment.

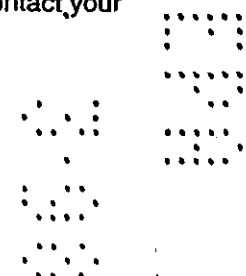
