The amendment referred to above, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) or 4(a) when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a., Delete the term "General" in the heading on the labeling. This term implies that the directions and restrictions do not all have to be followed as specified.

b. In the "Warranty Limitation and Disclaimer" section add the phrase "to the extent consistent with applicable law". It should be added so it is clear that the phrase applies to the whole warranty statement.

3. Submit one (1) copy of your final printed labeling before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

4. End use applications for federal registration under section 3 of FIFRA or State registration under section 24(c) of FIFRA must bear the following label restrictions:


a. Annual use directions on strawberries are limited to the States of Florida and North Carolina only.

b. For Bushberry, prohibit application to low-growing varieties.

A stamped copy of the label is enclosed for your records.

**Non-Agricultural Uses**

Turfgrass and lawn uses are restricted to non-residential sites. **Note:** In the states of California, Oregon and Washington, turfgrass and lawn uses are restricted to golf courses only. This product may be used to formulate products for specific use(s) not listed on this label, except residential turfgrass, if the formulator, user group or grower has complied with U.S. EPA submission requirements regarding the support of such use(s). Consult Dow AgroSciences for instructions for formulation and other information.
