of Formula To Comply with PR Notice 91-2 and
Labeling To Reflect Nominal Content of Active
Ingredient

The proposed Confidential Statement of Formula submitted on EPA Form 6570-4, dated February 25, 1994; and which reflects the nominal content of clopyralid in the subject product has been reviewed and found acceptable. Toxicological concerns for the impurities in the subject product will be addressed when the information that was submitted with your February 23, 1994 letter, addressed to Mr. Dennis Utterback of this Agency, has been reviewed.

The proposed amendment to the labeling of the subject pesticide product registration is acceptable under the Federal Insecticide, Fungicide and Rodenticide Act as amended, provided that you:

1. Comply with PR Notice 94-1, in regard to listing the use sites for which this clopyralid manufacturing-use product may be used for formulating EPA registered pesticide products.
2. Revise the Environmental Hazards statement to comply with PR Notice 93-10.
3. Submit five (5) printed copies of the final printed labels before releasing the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
