Your Submissions Dated August 28, 2008

The amendment referred to above, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

- 1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) or 4(a) when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a,. Delete the term "General" in the heading on the labeling. This term implies that the directions and restrictions do not all have to be followed as specified.

- b. In the "Warranty Limitation and Disclaimer" section add the phrase "to the extent consistent with applicable law". It should be added so it is clear that the phrase applies to the whole warranty statement.
- 3. Submit one (1) copy of your final printed labeling before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
- 4. End use applications for federal registration under section 3 of FIFRA or State registration under section 24(c) of FIFRA must bear the following label restrictions:
 - a. Annual use directions on strawberries are limited to the States of Florida and North Carolina only.
 - b. For Bushberry, prohibit application to low-growing varieties.

A stamped copy of the label is enclosed for your records.

Asparagus, barley, bushberries, canola, corn, crambe, cranberry, fallow land, flax seed, garden beet, grasses, head and stem *Brassica*, hops, mint, mustard greens, oats, pasture, rangeland, rapeseed, sod farms, spinach, stone fruits, strawberry, sugar beets, Swiss chard, tree plantations, turnip, and wheat. This product may be used to formulate products for specific use(s) not listed on this label, except residential turf, if the formulator, user group or grower has complied with U.S. EPA submission requirements regarding the support of such use(s). Consult Dow AgroSciences for instructions for formulation and other information.

Non-Agricultural Uses

Turfgrass and lawn uses are restricted to non-residential sites. **Note:** In the states of California, Oregon and Washington, turfgrass and lawn uses are restricted to golf courses only. This product may be used to formulate products for specific use(s) not listed on this label, except residential turfgrass, if the formulator, user group or grower has complied with U.S. EPA submission requirements regarding the support of such use(s). Consult Dow AgroSciences for instructions for formulation and other information.

This product **must not** be formulated into manufacturing-use herbicide products or end-use herbicide products for use on residential turfgrass.

Triple rinse or pressure rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for to seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and container at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. **Pressure rinse** as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.
