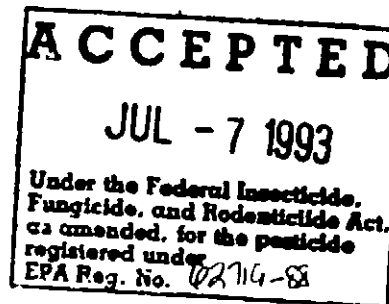

For a 0.5% rate, apply 13-1/3 fluid ounces of Dursban ME20 per 10 linear feet using no less than 2 gallons, or more than 8 gallons, of prefoamed dilution.

For a 0.75% rate, apply 20 fluid ounces of Dursban ME20 per 10 linear feet using no less than 2 gallons, or more than 8 gallons, of prefoamed dilution.

For a 1% rate, apply 26 2/3 fluid ounces of Dursban ME20 per 10 linear feet using no less than 2 gallons, or more than 8 gallons, of prefoamed dilution.

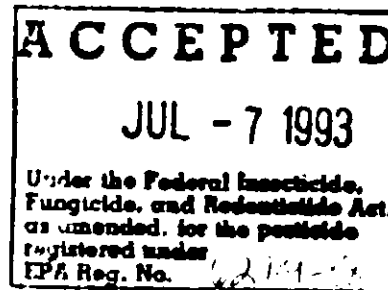
