Single Pass Incorporation Option for Treflan

ATTENTION

Treflan herbicide may be incorporated in a single pass if application conditions allow for thorough and uniform mixing into the top 2-3 inches of the final seedbed. Thorough and uniform incorporation may be achieved using the incorporation implements listed below if the soil at the time of application is of good tilth with moderate moisture and is relatively free of clods and trash.

Field Cultivators: With 3 or 4 rows of sweeps, spaced at intervals of 7 inches or less and staggered so that no soil is left unturned. Operate at a speed of 5 mph or more. Chisel points should not be used. Best results will be obtained when field cultivators are equipped with harrow, reel or basket attachments.

Finishing Disc: With disc blades no greater than 22 inches in diameter, spaced no more than 7 1/2 inches apart. Operate at a speed of 4 to 6 mph. Best results will be obtained when the disc is equipped with harrow, reel or basket attachments.

Combination Implement: With three or more tillage devices combined and used as a single tool. Operate at a speed of 5 mph or more.

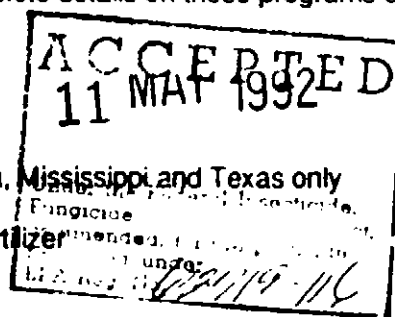
PTO Driven Equipment: Tillers, cultivators or hoes.

Precautions

Non-uniform incorporation may result in erratic weed control and/or crop injury. Incorporation should occur within 24 hours after application.

Two-pass incorporation is required for the following "Special Use Programs" and application methods. Consult the Treflan label for complete details on these programs and application methods.

- Fall panicum control
- Rhizome johnsongrass control
- Itchgrass (raoulgrass) suppression
- Red rice control in Arkansas, Louisiana, Mississippi and Texas only
- Wild cane (shattercane) control
- All Treflan applications with dry bulk fertilizer
