Precautions

- Do not apply to rapeseed (canola) grown in the state of Alaska.
- Where applications are made in late summer or fall, plant as rotation crops in the season following application only those crops to which Treflan may be applied as a preplant incorporated treatment or crop injury may occur.
- Do not graze or harvest treated crop for livestock forage.

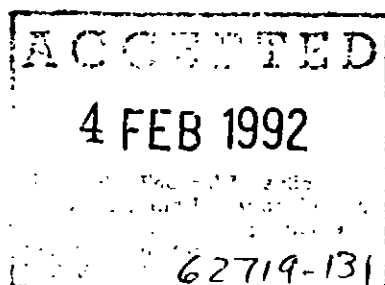
Directions for Use

Apply Treflan as a preplant soil incorporated treatment according to directions on the label of the Treflan product used.

Broadcast Application Rates per Acre:

| Soil Texture | Treflan E.C. or Treflan M.T.F. (pints) | Treflan 5 (pints) | Treflan 80DC (ounces) | Treflan TR-10 (pounds) |
|--------------|----------------------------------------------------------|---------------------------------|-------------------------------------|---------------------------|
| Coarse | 1 | 0.8 | 10 | 5.0 |
| Medium | 1 - 1.5 | 0.8 - 1.2 | 10 - 15 | 5.0 - 7.5 |
| Fine | 1.5 | 1.2 | 15 | 7.5 |

- Coarse soils with 2-5% organic matter - Apply 1.5 pints of Treflan EC or MTF, 1.2 pints of Treflan 5, 15 ounces of Treflan 80DC or 7.5 pounds of Treflan TR-10.
- Use higher rate in rate range where high weed populations are anticipated.
