

### Weed Control in Spearmint and Peppermint

#### **ATTENTION**

#### **Directions for Use**

Treflan\* TR-10\* herbicide may be applied to established spearmint and peppermint as a soil incorporated treatment to control weeds listed on the product label. Apply during dormancy or semi-dormancy in late winter or early spring or in the fall. Because Treflan TR-10 does not control established weeds, application must be made prior to the time of germination of target weeds. Late winter or early spring application will control susceptible weeds that germinate from early spring onward into the growing season and fall application will control susceptible fall germinating winter annuals. Use incorporation equipment that will ensure thorough soil mixing with minimal damage to the crop stand. Follow incorporation procedures in the product label for Treflan TR-10.

**Surface Applications Activated by Rainfall or Irrigation:** Surface applications of Treflan TR-10 may be activated by rainfall, sprinkler irrigation, or flood irrigation. Rainfall or a single overhead sprinkler irrigation of 0.5 acre inch or more is required to activate Treflan TR-10. If rainfall or irrigation has not occurred within 3 days after application, mechanical incorporation is recommended to activate the treatment.


