

Previously Submitted Changes Under the Ethalfluralin RED in label coded " C7A/Ethalfluralin Tech/Amend/04-19-96":

Revised the following statements to comply with language requirements required under the Reregistration Eligibility Decision (RED) document (EPA 738-R-95-001 March 1995):

1. Revised Environmental Hazards section by adding the phrase "and aquatic invertebrates" to the first sentence.

Proposed Changes by Amendment: The following changes are being submitted as directed in response to EPA's review of the 8-month response to the Ethalfluralin RED dated Feb. 22, 1999:

- 1. Signal word from "CAUTION" to "WARNING".
- 2. "Hazards to Humans and Domestic Animals" text revised.
- 3. "First Aid" statements revised.

Other:

- 4. KOROC statement deleted since it is not relevant to a manufacturing use product.
- 5. Added "Directions for Use" heading and placed "Storage and Disposal" at end of section.

DowElanco notified the EPA that its legal name will change to Dow AgroSciences LLC effective January 1, 1998. The following label changes are being made via non-notification as a result of this company name change:

- Company name changed from DowElanco to Dow AgroSciences LLC (logo, trademark reference, address line, warranty statement)
- Emergency telephone number updated to include a web site address (PR Notice 97-4)

The name of this product and its EPA registration number remain the same. No other changes are being made to the label at this time.

Final Printed Labeling: Label text based on EPA-accepted copy dated September 13, 1994.

Revisions Accepted 09/13/94:

- 1. Ingredients statement revised to reflect nominal concentration (see DowElanco submission dated January 13, 1994).
- 2. Added list of crops for which end-use herbicide products may be formulated.
- 3. Environmental Hazards: Revised effluent discharge statement in accordance with PR Notice 93-10.

Storage: Store in a cool, dry place. Store in original container. In case of leak or spill, contain material and dispose as waste.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Metal Drum Disposal: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. **Fiber Drum Disposal:** Completely empty fiber drum by shaking and tapping sides and bottom to loosen clinging particles.
