
The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, successfully REMOVES THE PRODUCT FROM THE SCOPE of PR Notice 93-7 once the comments (if any) on the attriched sheet are addressed. Other than the alterations (if any) listed on the attached sheet, no further alterations to the labeling are necessary to reflect the requirements or the Worker Protection Standard.

Since your amendment proposes to delete uses directly and/or to delete uses implicitly through the use of exclusionary statements, the Agency will publish in the Federal Register a notice of receipt of your amendment to delete uses, as required by section 6(f)(1) of FIFRA. The Agency will defer action for 90 days from the date of the Federal Register notice to give affected minor users an opportunity to try to persuade you to retain the uses(s). When the comment period has expired, the Agency will approve the amendment unless you have withdrawn it, and stamp the amended labeling "accepted." Your stamped-accepted labeling will then be sent to you.

As described in Supplement A of PR Notice 93-11 (self-verification option), you may sell and distribute product bearing the submitted labeling before you receive a copy of your stamped-accepted labeling. Note that your registration is not amended until the comment period required by section 6(f)(1) of FIFRA has expired and the Agency has approved the amendment. Therefore, you may withdraw your proposed amendment at any time during the comment period and until you receive your stamped-accepted labeling.

WARNING

Remove contaminated clothing and wash before reuse.

STATEMENTS OF PRACTICAL TREATMENT

If swallowed: Call physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger or, if available, by administering 1 to 2 table-spoons of syrup of ipecac. Do not induce vomiting or give anything by mouth to an unconscious person.

If on the skin: Wash with plenty of soap and water. Get medical attention if irritation develops.

If in eyes: Flush with plenty of water. Call a physician if irritation develops.

DIRECTIONS FOR USE - Read All Directions Carefully Before Applying

DowElanco's Turf Fertilizer containing BALAN can be used on the following established cool and warm season turfgrasses:

Established Cool Season Turfgrasses

- Bentgrass Fairways
- Kentucky Bluegrass
- Perennial Ryagrass
- Fescues

Established Warm Season Turfgrasses

- Bahiagrass
- Bermudagrass
- Cantipedegrass
- St. Augustinegrass
- Tall Fescue
- Zoysiagrass

This product is a granular fertilizer containing BALAN a preemergence herbicide which is applied to established turfgrasses for the control of the winter annual grass: annual bluegrass (Poa annua); and summer annual grasses: smooth and hairy crabgrass, goosegrass (silver crabgrass or crowfootgrass), barnyardgrass (watergrass) and green and yellow foxtail. Turf fertilizer containing BALAN controls these weeds by killing their seeds as they germinate. Apply this product before these annual weeds germinate since it does not control established weeds. This product will not harm most nearby established ornamentals.

APPLICATION DIRECTIONS

Rates and Frequency of Application:

This product should be applied one to two weeks prior to the anticipated germination of the target annual grass weeds. If application time does not coincide with the normal germination period of any of the annual grass weeds listed on this label, weed control may be erratic or poor. Optimum weed control performance will be obtained if treated areas are irrigated soon after application.

Do not apply this product to sod farms or turigrasses grown for seed, including plants or plant materials grown for sale or research purposes.

Broadcast Application Rates:

Cool Season Turfgrasses Warm Season Turfgrasses

240 lbs./acre Summer Annual 160 lbs./acre

Grass Weeds (3.7 lbs./1000 sq. ft.) (5.5 lbs./1000 sq. ft.)

Winter Annual 160 lbs./acre 240 lbs./acre

Grass Weeds

In areas with extended growing seasons or where desired, a second application at the recommended rate can be made 8 to 10 weeks following the initial application on cool season turfgrasses and 10 to 12 weeks following the initial application on warm season turfgrasses.

RESEEDING

Chemicals that effectively control annual weed species may also effect new desirable turfgrass seedlings. Reseeding should be delayed for at least 6 weeks after an application rate of 160 pounds per acre and 12 to 16 weeks after an application rate of 240 pounds per acre. س سے س

APPLICATION EQUIPMENT

Applications should be made using a properly calibrated granular fertilizer spreader which will uniformly distribute the product over the target area. Avoid skips and excessive overlaps as poor weed control or turfgrass injury may occur.

GENERAL USE PRECAUTION

Do not apply this product to golf course putting greens, dichonara, or newly sprigged areas of bermudagrass, St. Augustinegrass, centipedegrass, or zoysiagrass. Any cultural practices that disturb the soil, such as aerification or verticutting, should be done prior to application.
