Turf fertilizer containing Team 0.92% also provides partial control of prostrate spurge (*Euphorbia humistrata*), spotted spurge (*Euphorbia maculata*), creeping spurge (*Euphorbia maculata*), creeping woodsorrel (*Oxalis comiculata*) and yellow woodsorrel (*Oxalis stricta*).

Important Use Precautions

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

Reseeding: Do not reseed treated areas for minimum of 8 weeks after a single application of 217 pounds per acre or 12 to 16 weeks after a single application of 326 pounds per acre. For split applications, do not reseed treated areas for 8 to 10 weeks after the last 163 pounds per acre rate or 10 to 12 weeks after the last 217 pounds per acre rate.

Do not apply this product to golf course putting greens, dichondra, or newly sprigged areas of bermudagrass, St. Augustinegrass, centipedegrass, or zoysiagrass. Any cultural practices that disturb the soil, such as aerification or verticutting, should be done prior to application.

Application

This product should be applied one to two weeks prior to the anticipated germination of the target annual weeds. Apply using a properly calibrated granular fertilizer spreader which will uniformly distribute the product over the target area. Avoid skips and excessive overlaps as poor weed control or turigrass injury may occur. Optimum weed control performance will be obtained if treated areas are irrigated soon after application. This product will not harm most nearby ornamentals.

In areas with extended growing seasons or where desired, a second application at the recommended rate can be made 8 to 10 weeks following the initial application on cool season turigrasses and 10 to 12 weeks following the initial application on warm season turigrasses.

Split Applications for Extended Control and Lawn Care Operator Programs:

As an atternative to single application programs, DowElanco Turf Fertilizer containing Team may also be applied in split applications. This program is desirable when the initial application is made well in advance of weed germination and where weed control is desired for a longer period of time.

Apply DowEianco Fertilizer containing Team at 163 pounds plus 163 pounds per acre for Cool Season Turfgrasses and in the northern half of the Warm Season Turfgrass area of the U.S. or 217 pounds plus 217 pounds per acre in the southern half of the Warm Season Turfgrasses area of the U.S. The second application should be made 8 to 10 weeks following the 163 pounds per acre rate and 10 to 12 weeks following the 217 pounds per acre rate.
