Application

This product should be applied one to two weeks prior to the anticipated germination of the target annual weeds. Apply using a properly calibrated granular fertilizer spreader which will uniformly distribute the product over the target area. Avoid skips and excessive overlaps as poor weed control or turigrass injury may occur. Optimum weed control performance will be obtained if treated areas are irrigated soon after application. This product will not harm most nearby ornamentals.

In areas with extended growing seasons or where desired, a second application at the recommended rate can be made 8 to 10 weeks following the initial application on cool season turigrasses and 10 to 12 weeks following the initial application on warm season turigrasses.
