Dear Mr. Fitt:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

- 1. Delete "More active on fleas than sevin, diazinon, malathion, permethrin, pyrethrins, resmethrin" as a claim.
- 2. Delete "New faster acting formula" and "Faster acting formula" as claims. No data have been submitted to support the claim "faster".

(Note that the claims referring to a "new" formula are acceptable, but can be used only for the first six months that the product is marketed with labeling containing these claims.)

- 3. Delete the claim "Keeps on killing roaches for up to 8 weeks." We have submitted the study for efficacy review, and upon completion of the review it may be possible to use the claim. Has this study (Report No:93JJBU052/Project No:93-603) previously been submitted to the Agency? If so, please identify it by MRID Number.
- 4. The claims "For use in and around the home" and "Replaces home pest insect control" are acceptable. The sentence "For indoor and outdoor home use only" in the precautionary statements (page 5 of the draft label) is also acceptable. It is assumed that if the product is marketed

for homeowner use, labeling will contain these limitations. In this case, however, the section in the directions for use, "Application within Food Handling Establishments..." (page 7 of the draft label), cannot appear on the label.

- 5. In the ingredients statement correct the spelling of N-Octyl-Bicycloheptene Dicarboximide, and replace the concentration of Piperonyl Butoxide, Technical in the column with the other concentrations.
- 6. In the directions for the control of fleas and brown dog ticks, revise the sentence "Treat pets with a product labeled for this use" to "Treat pets with a product registered for this use." The sub-registrant may not specify an actual product, but may suggest one ("...registered for this use, such as...").
- 7. On page 8 of the draft label delete the section, "SUGGESTION: To improve control..."
- 8. Labeling for larger containers sold only to refill the smaller, spray containers must include text that specifies this limitation, for example:

To be used only to refill spray containers of ORTHO Home Pest Insect Control.

Labeling for the smaller, spray containers must include text such as:

To be refilled only with ORTHO Home Pest Insect Control.

The alternate formulation indicated on the Confidential Statement of Formula, dated August 1, 1994, is acceptable and has been added to our files for the product.

Submit five (5) copies of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.



 - (b) Revised storage directions to reflect special considerations for trigger sprayers.
