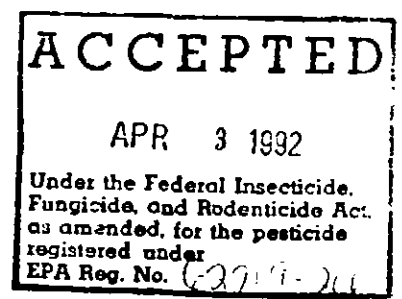

Harmful If Swallowed

Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs, and domestic water supplies. Wash thoroughly after handling. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray as specified on the label. Remove pets and cover fishbowls before spraying.

Note to Physician: Active ingredients contain a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

First Aid

If swallowed: Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. Call a physician immediately. Do not induce vomiting or give anything by mouth to an unconscious person.

If inhaled: Remove victim to fresh air. Apply artificial respiration if indicated.

If on skin: Remove contaminated clothing and wash affected areas with soap and water.

If in eyes: Flush eyes for at least 15 minutes with water. Call a physician immediately.

STORAGE AND DISPOSAL

Storage: Store in original container in a cool, dry place inaccessible to children or pets. Protect from freezing.

Container Disposal: Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.

SURFACE SPRAY

Shake well before using. Spray infested surfaces until wet, but avoid excessive runoff.

To control Ants, Boxelder bugs, Centipedes, Cockroaches, Crickets, Earwigs, Pillbugs, Scorpions, Silverfish, Spiders, Spider Beetles, Waterbugs: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, in walls; along and behind baseboards, door sills and frames; behind and beneath sinks, stoves, refrigerators and cabinets; and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be sprayed directly.

To Control Ants: Treat ant trails, nests and points of entry. Repeat treatment as necessary.

To Control Carpet Beetles, Cigarette Beetles and Clothes Moths: Spray edges of carpeting and under carpeting, rugs and closets. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

To Control Fruit Flies, Gnats, House Flies, Mosquitoes, Small Flying Moths: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures, on porches, in garages and other places where these insects alight or congregate. Retreat as necessary.

For Control of Fleas and Brown Dog Ticks: Thoroughly apply as a spray for spot treatment to infested areas, nearby cracks and crevices and along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. For best results, old bedding should be cleaned or replaced. **Do not treat pets or their bedding with this product.** To control the source of flea infestation, pets inhabiting the treated premises should be treated with a product registered for application to animals.
