Dear Dr. Jachetta:

The revised labeling referenced to above, submitted in connection with the registration under the Federal Insecticide, fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable provided that you make the labeling changes indicated before you release the product for shipment bearing the amended labeling:

- 1) Add the following under the "Restrictions" heading: "Treat only the lower 4 feet of the trunk."
- Add the following statement requested by SRRD under the "Restrictions" heading: "If the available residue data submitted in 2002 demonstrates that detection of chlorpyrifos at concentrations greater than 0.01 ppm. then DowAgroSciences agrees to discuss further mitigation."

DowAgroSciences must state in writing that they agree to the condition specified in item  $\pm 2$  above, before releasing product for shipment bearing the supplemental labeling.
