To Add Supplemental Labeling To Add the Use of  
Methylated Seed Oil Applied Postemergence,

The subject request to amend the registration of Hornet by adding supplemental labeling has been reviewed and copy of the review is enclosed for your records. The proposed labeling amendment has been reviewed and found acceptable under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, provided that you:

1. Add a use restriction that reads as follows:

- o If you use this product as directed in this supplemental labeling, you must not apply any other herbicide product that contains the active ingredients, clopyralid and/or flumetsulam, during the crop year, which would exceed an accumulative dosage of a maximum of 0.25 lb a.i./A/ year clopyralid or a maximum of 0.07 lb a.i./A/year flumetsulam.

2. Revise all labeling of crop use products that claim clopyralid and/or flumetsulam by adding a use restriction that will assure that the maximum annual use of the active ingredients clopyralid and/or flumetsulam will not exceed the maximum use rates: 0.25 lb a.i./A/year for clopyralid and 0.07 lb a.i./A/year for flumetsulam. The use restriction must read similar to that stated in 1 above. This may be done by notification, if the use restriction reads similar to that stated in 1 above. A list of the EPA registered pesticide products containing these active ingredients is enclosed for your use.

3. Submit one (1) copy of your final printed labeling prior to your shipment of the subject pesticide product under the enclosed stamped labels.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, section

6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the proposed label is enclosed for your records.

### Use of Methylated Seed Oil with Hornet Applied Postemergence

#### ATTENTION

#### Directions for Use

Hornet\* broadleaf blend herbicide may be used with crop oil concentrates that includes methylated seed oil to improve weed control under dry conditions. Methylated seed oil, a vegetable seed-based oil, may be used at a rate of 1.0 % v/v (1 gal per 100 gal of spray solution). It is recommended in combination with an agriculturally approved sprayable liquid fertilizer or ammonium sulfate when susceptibility to herbicides is reduced by dry conditions prior to application of Hornet.

Refer to the product label for Hornet for complete Directions for Use and specific information on broadleaf weeds controlled.
