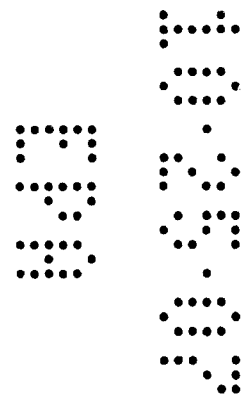

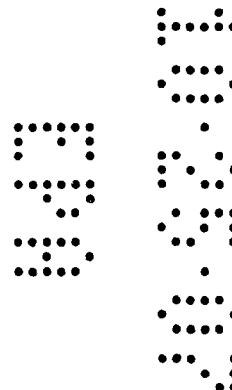

In Florida, Shatter™ termite bait may be installed for protection of new structures in lieu of a preconstruction termiticide treatment. During the year following installation of the termite baiting system, termite stations baited with Shatter must be inspected monthly. Thereafter, baited termite stations may be inspected as specified in the "Monitoring" section of the label booklet for Shatter.

**Note:** These preconstruction treatment instructions supersede prior instructions restricting the use of Shatter in lieu of a pre-construction termiticide (chemical barrier) treatment in the state of Florida.
