General information

Frontrow* herbicide is a co-pack product, for posternergence broadleaf weed control in soybeans. Each co-pack (overpack) of Frontrow contains 1.5 oz of FirstRate* herbicide and .6 oz of Flurnetsularn 80 WDG herbicide in separate water soluble paciets. Frontrow is formulated as water dispersible granules. The individual components of the Firentium co-pack must be used together or a reduction in weed control will result. Do not mix and apply separately.

When applications are made under advarse (dry or cold) conditions or when large weeds or less susceptible species are treated, weed suppression may be observed. Weed suppression is a visual reduction in weed competition (reduced population, size, and/or vigor) as compared to an untreated area. Degree of competition be increased by applying Frontrow under good growing conditions (i.e., adequate moisture).



Safe Pesticide Handling Procedures

Handling Precautions for Product Packaged in Water Soluble Packets: Do not remove water soluble packet from overpack except for immediate use. Do not allow water soluble packet to come into contact with water prior to use. Do not handle water soluble packet with wet hands or wet gloves. Carefully reseal overpack containing unopened water soluble packets and protect package from moisture.

Rotational Crop Restrictions:

- When tank mixing with other herbicides, follow crop rotation guidelines on the label of each product used.
- The following rotational crops may be planted at the indicated interval following application of Frontrow.

**Note: Rotation to sugar beets, sunflowers, tobacco, canola and all other crops requires a 26 month rotation interval and a successful field bioassay.



Fleld Bloassay Instructions: Using typical tillage, seeding practices, and timings for the particular crop, plant several strips of the desired crop variety across the field previously treated with Frontrow. Plant the strips perpendicular to the direction Frontrow was applied. The strips should also be located so that different field conditions are encountered, including differences in soil texture, pH, and drainage. If the crop does not show visible symptoms of injury, stand reduction, or yield reduction, the field can be seeded with the test crop in the growing season following the bioassay. If visible injury, stand reduction, or yield reduction occurs, the test crop should not be seeded, and the bioassay must be repeated the next growing season.

Mixing and Application

Spray Volume and Application: Apply in a total spray volume of 10 to 20 gallons per acre. Use sufficient spray volume to provide uniform coverage. Sufficient agitation should be maintained during mixing and spraying to ensure a uniform spray mixture. Apply with ground equipment using standard low pressure (20 to 40 pounds per square inch) herbicide sprayers equipped with flat fan nozzles. Do not apply using liquid fertilizer as carrier.

Mixing - Frontrow Alone

Water Soluble Packaging: Each Frontrow co-pack (overpack) contains two water soluble packets which must be removed from the overpack and added to the spray tank at the same time. Refer to Application Rates below to determine the number of co-pack units (each containing two water soluble packets) that must be added to the spray tank for the acreage to be treated. Thorough mixing is required.

Mixing Instructions:

- 1. Fill the tank with 1/2 of the total amount of water or liquid fertilizer required.
- 2. Start agitation system.


- 3. Add any adjuvant materials, and then add the required number of co-pack units (each containing two water soluble packets) to the spray tank.
 - Note: Handling water soluble packets with hands should be minimized. Do not handle if hands or gloves are wet. Water soluble packets must be removed from the overpack before adding to the spray tank. This can be done by opening the overpack and adding the two water soluble packets (product in transparent film) directly to the spray tank. Do not open water soluble packets. Water soluble packets will float on the surface until the soluble film dissolves and the product is released. Overpacks are not water soluble and should not be placed in spray tank.
- 4. Continue agitation and complete filling the tank while the packets dissolve.
- 5. Before spraying, make sure packets have completely disintegrated and product is thoroughly mixed with water. Depending on the water temperature and the degree of agitation, the packet and its contents should be completely dispersed within 5 minutes from the time they were added to the spray tank.

Screens in spray tank lines should be no finer than 50 mesh (100 mesh is finer than 50 mesh).

A STATE OF THE STA

To insure a uniform spray mixture continuous agitation is required during mixing and spraying. Apply within 24 hours after mixing. If product is allowed to settle, thoroughly agitate to resuspend the mixture before spraying.

Pre-mixing (other products): If pre-mixing is required for other dry or flowable products applied in tank mix combination with Frontrow, follow recommendations for pre-mixing of such products provided in their respective product labels.



Mixing - Frontrow in Tank Mix Combination

Vigorous, continuous agitation during mixing, filling and throughout application is required for all tank mixes. Sparger pipe agitators generally provide the most effective agitation in spray tanks. To prevent foaming in the scray tank, avoid stirring or splashing air into the spray mixture. To prevent foaming during filling, keep end of fill pipe below the surface of the liquid in the spray tank.

Compatibility Testing: When tank mixing Frontrow with other products, a compatibility test (jar test) using relative proportions of tank mix ingredients should be conducted prior to mixing ingredients in the spray tank. Use a compatibility agent if the need for one is indicated by the jar test (ingredients separate readily and are rot easily redispersed).

Mixing Order for Tank Mixes:

- 1. Fill the spray tank to 1/4 to 1/3 of the total spray volume required with water.
- 2. Start agitation system.
- 3. Add different formulation types in the following order: (1) Compatibility agent, if required; (2) Frontrow and other dry flowables; (3) wettable powders; (4) aqueous suspensions, flowables and liquids. Maintain agization and fill spray tank to 3/4 of total spray volume and add: (5) emulsifiable concentrates: and (6) solutions. Allow time for complete mixing and dispersion after addition of each product.
- 4. Finish filling the spray tank. Maintain continuous agitation during mixing, final filling and throughout application.

If spraying and acitation must be stopped before the spray tank is empty, the materials may settle to the bottom. Settled materials must be resuspended before spraying is resumed. A sparger agitator is particularly useful for this purpose. Settled material may be more difficult to resuspend than when originally mixed.

Application Rates

Each co-pack (orespeck) of Frontrow, containing 1.5 oz of FirstRate and .6 oz of Flumetsulam 80 WDG, will treat 10 acres. The following table provides per acre rates of Frontrow when applied according to table directions. Note: Open the overpack and add both of the water soluble packets directly to the spray tank. The overpack is NOT water soluble.

Approved Uses

SOYBEANS

Postemergence Application

Apply Frontrow at a rate of 1 co-pack (containing 1.5 oz of FirstRate and .6 oz of Flumetsulam 80 WDG) per 10 acres. Apply as a broadcast spray when weeds are actively growing and before weeds exceed the growth stages (number of true leaves per plant) indicated in the table below. Applications made to larger weeds or to weeds under stress may result in unsatisfactory control. Application timing generally corresponds to soybean growth stages of unifoliate to three to four expanded trifoliate leaves. Frontrow may be applied alone or in tank mix combination with other posternergence herbicides. Applications of Frontrow must include either a crop oil concentrate, a nonionic surfactant or a nonionic surfactant plus urea ammonium nitrate.
