On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or carcel the registration of a pesticide in accordance with the Act. The studies referred to above were conducted on Tracer (EPA Reg. No. 62719-267). The subject product (62719-EOT) is essentially a dilution of that product with the addition of two ingredients in low percentages. The study cited for eye irritation indicated a toxicity category IV hazard potential; however, the presence of these two additional ingredients in the subject formulation may result in a slight increase in eye irritation potential. Therefore, in the absence of an eye irritation study for this product, the toxicity category by this exposure route should be III. I have enclosed a copy of the acute toxicity review for your perusal.

Change the Precautionary Statements on pages 1 and 4 to read as follows: "Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling."

Change the First Aid statement on pages 1 and 4 to read as follows: "If in eyes: Flush eyes with plenty of water. Call a physician if irritation persists."

- c. In the Environmental Hazards statement on page 1 and 4, the first sentence should read "This product is toxic to aquatic invertebrates."
- d. On page 3, change the sentence "Refer to inside of label booklet for additional..." to "Refer to inside of label booklet for Directions for Use including Storage and Disposal."

General Information

Precise* insect solution is to be used for localized remedial treatment of drywood (Kalotermitidae) termites.

Precise insect solution is a ready to use suspension formulation (Shake well before use). Precise insect solution will not penetrate intact wood and for effective control must be applied directly into the termite gallery. Precise insect solution is most efficacious when applied to areas where termite activity is greatest.

Application


Effective use of this product requires galleries to be located. Visual signs of infestation such as frass or pellets, blistered wood, emergence or "pellet kick-out" holes, and live insects can be used to locate nests and galleries within wood. Galleries may be located by tapping on the wood surface and listening for changes in sound to indicate changes in wood density.

Application Equipment: Shake the pouch containing Precise insect solution well before applying. Apply Precise insect solution using the Precise injector. Do not use the Precise injector where electrical shock could occur.

Wood Injection: Drill small-diameter holes of appropriate size for the injection tip to intersect termite galleries within infested wood. Drywood termite emergence or pellet kick-out holes connect directly to galleries and are indicators of potential sites to drill and inject Precise insect solution. Care should be taken to avoid electrical wiring, plumbing, etc., when drilling. Do not drill completely through wood. Spacing of the holes will depend on the distribution of insect activity and galleries. Injection holes may be clustered in areas with insect activity as indicated by damage, live insects, or other indicators previously described. Injection holes on opposite sides of large (4" x 10" or larger) structural beams may be necessary to effectively penetrate galleries.

Follow recommendations for the Precise injector to avoid splashback when injecting Precise insect solution. Apply up to 50 ml of Precise insect solution using the Precise injector at each injection hole. Precise insect solution must be injected directly into the termite galleries. It is not necessary to inject Precise insect solution until runoff is detected from other holes. For best results, holes should be plugged after treatment. Use inert materials such as a wooden dowel or a touch-up stick for wood surfaces to minimize the possible disturbance of termites from entry of fresh air into galleries.

Retreatment guidelines: Reapply if insect activity within treated areas is detected four or more weeks following treatment. For best results in treating galleries, inject Precise insect solution into new injection holes drilled between previous injection sites.
