Dear Dr. Jachetta,

The revised product labeling referred to above, submitted in connection with the registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable, provide you incorporate the Agency's conditions as enumerated in this letter below and submit two copies of you final printed label prior to releasing the product for shipment.

- 1. Under the list of pests controlled on page 1, remove "Controls fire ants and/or For mound treatment control of imported fire ants" since specific directions for individual mound treatment are not provided in the Directions for Use.
- 2. On page 4, delete "Spreader Settings/Helpful Advice for Application" and the accompanying editor's note. The label of the distributor product must be the same as the registered product except for the product name, the name and address of the distributor, and the registration number followed by the distributor's company number. (40 CFR 152.132(d))

The conditions of paragraph 5 of the June 2000 Memorandum of Agreement apply to this label amendment, specifically this amended label is effective December 1, 2000. Failure to comply with any of the conditions of registration set forth in Paragraph 10 of the MOA shall be grounds for cancellation of the affected registration(s) under FIFRA section 6(e).

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.



# Hazards to Humans and Domestic Animals

# **CAUTION**

Harmful if swallowed, or absorbed through the skin. Avoid breathing dust and contact with eyes, skin or clothing. Keep public including children and pets off treated areas until this product is washed into the soil and grass is dry. Wash thoroughly after handling and before smoking or eating. Keep away from food, feedstuffs, and domestic water supplies.

# First Aid

If swallowed: Call a physician or poison control center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

If on skin: In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.

If in eyes: Flush eyes with plenty of water.

Note to physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

#### **Environmental Hazards**

This product is extremely toxic to fish, birds and other wildlife. Do not apply directly to water. Do not apply where runoff is likely to occur. Do not contaminate water when disposing of equipment washwaters. Do not feed treated grass clippings to livestock.

### **Directions for Use**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read all directions carefully before applying this product.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

#### Storage and Disposal

Do not contaminate other pesticides, fertilizers, seeds, water, food or feed by storage or disposal.

Storage: Always store product in original container and in locked storage area.

**Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**Container Disposal:** Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Note: Mosquitoes coming to rest on areas treated for control of turf pests will be confrolled for varying. periods of time after treatment, depending on exposure of treated areas to weather conditions.

Treat when insects are active or as recommended by state agricultural experiment stations or state extension service specialists.

Apply this product uniformly to golf course turfgrass areas using any land or power operated gravity or rotary type spreader designed for application of granular materials. This product is not for pasture use. To obtain uniform distribution, apply one-half the required amount of product in one direction; then apply the balance at a right angle.

Immediately after application, lightly water using 30 gallons per 1000 sq ft of area.

After 2 to 3 days, water again applying about an inch of water. Rainfall during this period may be counted, but should be measured.

#### Rates to Use

To control ants, brown ticks, chinch bugs, crickets, cutworms, earwigs, sod webworms and sow bugs, use the product at a rate of 3.3 lb of product per 1,000 sq ft. This package will treat 10,000 sq ft (100 X 100 area) at the above rate.
