Your Amendment dated June 23, 2011, Proposed new plant back interval time periods for all registered labeled uses  
PRIA Decision No. 451117

Dear Dr. Brinkmeyer:

The amended master label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided that you revise the following:

Pages 1 and 6, "User Safety Requirements," place section inside of a text box, and adjust the font size of the heading.

Pages 2 and 7, "Environmental Hazards," third paragraph, revise the sentence to read: Do not apply this product one-half hour before dusk to one-half hour after dawn in counties east of the Rocky Mountains where the gray bat, Indiana bat, and the Ozark big-eared bat occur. Additionally, reposition this sentence under "Directions For Use" (prior to the Agricultural Use Requirements Box).

Page 10, "Application Method" section, revise first sentence to read: "Apply uniformly by ground application in a minimum spray volume of 30 gallons per acre except as noted in the supplemental labeling."

Pages 10, 16, 18, 20, 22, 24, 26, and 28 under "Application Method" for ground and/or aerial, remove the word "excessive" with respect to spray drift.

The supplemental labels referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended are acceptable provided that you revise the following:


Pages 16, 18, and 20 [supplemental labeling for stone fruits (excluding cherries); [winter squash, gourds, and pumpkins; and artichoke, respectively], the following language is to be used and should be prominently located towards the top of each label: "This supplemental label expires on **March 15, 2015** and must not be used or distributed after this date."

Page 16, "Application Method" section, revise the first sentence to read: "Apply uniformly by ground application in a minimum spray volume of 30 gallons per acre except as noted in the supplemental labeling."

Pages 22, 24, 26, and 28 [supplemental labeling for pepper, melons (subgroup 9A), strawberry, and lettuce, respectively] the following language is to be used and should be prominently located towards the top of each label: "This supplemental label expires on **March 15, 2015** and must not be used or distributed after this date."

One copy of the main and supplemental labels stamped "Accepted with comments" are enclosed for your records. Please submit one copy of the final printed labels that incorporates the required changes before the product is released for shipment.
