

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. In the STORAGE AND DISPOSAL section make the following changes:
 - Add "Pesticide" in front of the "Storage" subheading.
 - Add "If drum is contaminated and cannot be reused, dispose of it in the manner required for its liner" to the end of the "Container Disposal" subheading.
2. In the HAZARDS TO HUMANS AND DOMESTIC ANIMALS section make the following change:
 - Add "and before eating, drinking, chewing gum, or using tobacco" to the end "Wash thoroughly with soap and water after handling."

Submit three (3) copies of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted labels. A stamped copy of labeling is enclosed for your records.
