For best control of labeled diseases, achieve thorough coverage of all plant parts on a protective application schedule. For dilute application sprays (>100 gallons of spray volume per acre) applied to ornamental plants in greenhouses, field grown plantings or in commercial and residential landscapes, apply Eagle 20EW at the rate of 6 to 12 fl oz per 100 gallons of spray volume on a 10- to 14day application schedule unless otherwise directed. Use the higher rate under conditions of high disease pressure and/or optimum conditions for infection.
