How to Apply

Apply Penoxsulam FERT 0.014% using a drop or rotary-type spreader designed to apply granular herbicides or insecticides. Calibrate application equipment prior to use according to manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly. Do not use spreaders that apply material in narrow concentrated bands. Avoid skips or overlaps as poor weed control or turfgrass injury may occur. More uniform application may be achieved by spreading half of the required amount of product over the area and then applying the remaining half in swaths at right angles to the first.

Mow the turfgrass two to three days before applying Penoxsulam FERT 0.014%. Application Techniques for Applying Penoxsulam FERT 0.014%

- When using a drop-type spreader, a splashboard mounted under the hopper will provide more even granule distribution.
- A chain fastened to the side of the spreader and allowed to drag on the soil surface can be used to mark the edge of the treated swath and help prevent skips or overlaps.
- For treating smaller areas, a hand held or push-type rotary applicator such as a whirlybird or cyclone unit is recommended. For hand held units, walk and turn the crank at a constant rate of speed.
- A shaker-type applicator made from a small container with holes punched in the bottom is recommended for small, difficult to treat areas. Carefully measure the amount of product needed to avoid over application.
