4. Within a year, submit a seedling emergence study (850.4100) with the major degradate, 5-OH-XDE750.

5. Within a year, submit an independent laboratory validation study for the Florasulam method in soil entitled, "Residue Method Validation Report for the determination of DE-570 (Florasulam) and the 5-Hydroxy Florasulam Degradate in Soil by Capillary Gas chromatography with mass Selective Detector."

6. Within 6 months, submit a copy of the enforcement analytical method to the EPA Analytical Laboratory at the following address:
