- 1. An immunotoxicity study is now required under the revised 40 CFR 158, within one year of the date of this letter <u>or</u> with the submission of any additional new uses to these labels, whichever is sooner.
- 2. Specify a retreatment interval on the end-use label (62719-560).

Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

(Storage and Disposal for refillable rigid containers larger than 5 gal)

Storage and Disposal

Do not contaminate water, food or feed by storage and disposal. Open dumping is prohibited.

Pesticide Storage: Store in a cool, dry, well-ventilated place. Store in original container only. In case of leak or spill, contain material and dispose as waste.

Pesticide Disposal: Waste resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal.
