

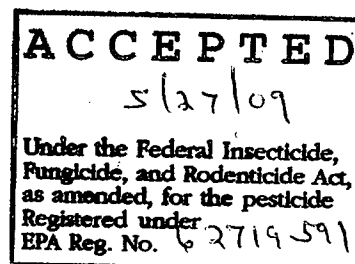

Directions for Use

Refer to product label for Lorsban Advanced for Use Precautions and Restrictions, Mixing and Application instructions.

Mix with water and apply directly to trunk from a distance of no more than 4 ft using low volume handgun or shielded spray equipment. Do not allow spray to contact foliage or fruit.

Specific Use Restrictions:

- **Worker Restricted Entry Interval:** Do not enter or allow worker entry into treated areas during the restricted entry interval of 4 days unless PPE required for early entry is worn.
- **Preharvest Interval:** Do not apply within 28 days before harvest.
- Do not make more than one application of Lorsban Advanced to the apple tree trunk per year as either a pre-bloom or post-bloom application.
- This product may not be used if a pre-bloom application of any other product containing chlorpyrifos has been made during the year.
- Do not allow meat or dairy animals to graze in treated orchards.

- Treat only the lower 4 feet of the apple tree trunk.
- Do not apply when wind speed is greater than 10 mph.
- Handlers and workers making applications by groundboom sprayer must wear basic protective clothing (long-sleeved shirt, long pants, socks and shoes), gloves, and a respirator with a protection factor of 5 (PF5); workers making applications by shielded hand gun must wear basic protective clothing (long-sleeved shirt, long pants, socks and shoes), coveralls and gloves.
