For selective postemergence control of broadleaf weeds in Barley, Brassica, Head and Stem Vegetable Group (Crop Group 5-16), Bushberry subgroup (Crop Subgroup 13-07B), Canola, Christmas tree plantations, Conservation reserve program (CRP) acres, Corn (field, pop, sweet), Cottonwood/poplar and eucalyptus tree

Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Pressure rinse** as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Then offer for recycling if available, or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures allowed by state and local authorities.
