



Treated outer clothing, netting and tentage provides protection to covered areas of body from bites of mosquitoes, ticks, chiggers, and human body lice. Fabrics to be treated are described in MIL-C-43468, CLOTH, CAMOFLAGE PATTERN: WIND RESISTANT POPLIN, COTTON; MIL-C-44031 CLOTH, CAMOFLAGE PATTERN: WOODLAND COTTON AND NYLON; AND MIL-C-44034 CLOTH, TWILL, CAMOFLAGE PATTERN, COTTON AND NYLON FOR DESERT UNIFORM.

<u>Application Procedure</u>: Apply 40% permethrin/water emulsion to MILITARY SERVICE FIELD UNIFORMS OR EQUIVALENT THAT IS APPROVED FOR TREATMENT using the Metered Addition of Chemicals method resulting in a treatment level of 0.52% weight by weight of active ingredient.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE AND SPILL PROCEDURES: Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.
