

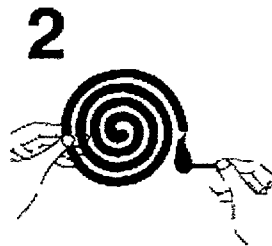

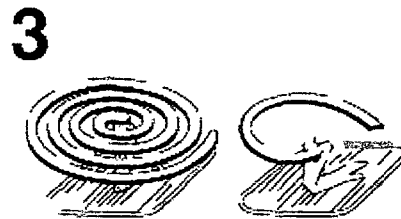
Loosen coils until ends move freely Grasp each comma shaped end in the center between thumb and forefinger or each hand and separate the two coils by gently pressing them apart Hold one comma shaped end and shake lightly or gently pry to separate the coils Insert top of coil stand into slot in comma shaped end of coil Light the outer end of the coil and let burn (flame) approximately ¼ inch or less Blow out the flame and allow the coil to smolder until extinguished For shorter periods of use break the coil into desired length and place in notched cut out of holder For best results do not use in wind Coil burns [2 4] [4 6] 6 8 hours in still air
