DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Open foil pouch and remove one Family mosquito Repellent Mat. Slip mat into slot and onto heating element of vaporizer, then plug vaporizer into outlet. Family Mosquito Repellent Mats efficiently destroys mosquitoes and flies in a room of up to 2,300 cu.ft. (approximately 15 x 19 x 8 ft.). One mat lasts ten hours. The mat turns white when the active ingredient has been exhausted. To remove spent mat: unplug vaporizer, turn sideways and allow the spent mat to fall out. For indoor use only when mosquitoes are an annoyance. Do not use in rooms while people are sleeping.

STORAGE: Store mats in unopened pouch in a cool, dry (preferably locked) place, inaccessible to children and pets.

DISPOSAL: Do not reuse empty pouches. Discard in trash. Securely wrap used mats in several layers of newspaper and discard in trash.

Hazards to Humans & Domestic Animals

CAUTION: Harmful if inhaled. Avoid breathing vapors. Remove pets from and cover aquariums in rooms being treated. Do not insert articles other than Family Mosquito Repellent Mats into heater. Do not cover vaporizer with cloth or other material.

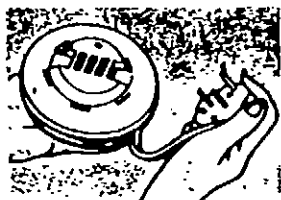

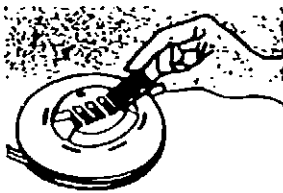

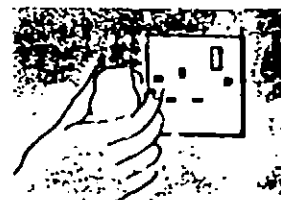
