TIPS: pay particular attention to rot prone areas (stem, keel, chine, windshield corners, anywhere two pieces of wood come together).

The wetting process may need to be repeated several times over a 24 hour period to achieve maximum penetration.

Application may also be made by drilling and then injecting the solution directly into the infested area.

Any residue can be washed off with warm water.

Any exterior area or area with excessive moisture should be coated with a water repellant after treatment, such as paint, varnish or epoxy.

SHIP-BOR may be irritating; Applicators and other handlers must wear: Dust mask and eye protection, Long sleeve shirt and long pants, chemical resistant or waterproof gloves, shoes plus socks.

Coverage: 100-150 sq. ft. / gallon average depending on wood porosity.

SHIP-BOR is recommended for all interior and exterior wood components which will be protected from rain and not in direct contact with water. The treatment of lumber is permanent even after cutting and finishing providing the wood is not exposed to excessive moisture or in direct contact with water.

This product is toxic to wood destroying insects but surface etching of treated wood may occur.
