### RESISTANCE MANAGEMENT

*Bolero* 15 G herbicide Herbicide is a Group 8 herbicide (lipid synthesis inhibition). Any weed population may contain or develop plants naturally resistant to *Bolero* 15 G Herbicide and other Group 8 herbicides. Resistant biotypes weed species with acquired resistance to Group 8 may eventually dominate the weed population if Group 8 herbicides are used repeatedly in the same field or in successive years as the primary method of control for targeted species. These resistant biotypes may not be adequately controlled by herbicides in a mode of action class for which resistance has developed. This may result in partial or total loss of control of those species by *Bolero* 15 G Herbicide or other Group 8 herbicides.

Other resistance mechanisms that are not linked to site of action, such as enhanced metabolism, may also exist. Appropriate resistance management strategies should be followed. If poor performance occurs and cannot be attributed to adverse weather or application conditions, a resistant biotype may be present. Contact your local extension specialist or certified crop advisor for additional pesticide resistance management and/or integrated weed management recommendations for specific crops and weed biotypes.

To delay herbicide resistance consider:

- Avoiding the consecutive use of *Bolero* 15 G Herbicide or other target site of action Group 8 herbicides that have a similar target site of action, on the same weed species.
- Using tank mixtures or premixes with herbicides from different target site of action Groups as long as the involved products are all registered for the same use, have different sites of action, and are both effective at the tank mix or prepack rate on the weed(s) of concern.
- Basing herbicide use on a comprehensive Integrated Pest Management (IPM) program.
- Monitoring treated weed populations for loss of field efficacy.
- Contacting your local extension specialist, certified crop advisors and/or manufacturer for herbicide resistance management and/or integrated weed management recommendations for specific crops and resistant weed biotypes.

## SPECIAL INSTRUCTIONS

Apply after flooding when rice is in the expanded two-leaf stage (first open leaf). Do not apply if rice exhibits symptoms of stress. The variety Cal Pearl may react adversely to some stress conditions more than other varieties.

Optimum size for [control] [suppression] of Barnyardgrass (Watergrass) is two (2) leaves or less. Optimum size for control of Smallflower Umbrellaplant is three (3) leaves or less. Barnyardgrass beyond the two-leaf stage and Smallflower Umbrellaplant beyond the three-leaf stage may not be controlled. Smallflower Umbrellaplant must be submerged for optimum control. Cold weather during the planting season may result in decreased weed control due to prolonged period of weed seed germination.

## SUGGESTED MANAGEMENT PRACTICES:

Bolero 15 G Herbicide use in rice fields which have received spring incorporation of high amounts (no straw burning or removal) of straw and/or green organic matter, may reduce plant stand and yield.

Suggested management practices which will help promote soil conditions conducive for the production of healthy rice treated with *Bolero* 15 G Herbicide include:

- Burn crop residue where state regulations allow or remove straw.
- Fall plowing/discing of crop straw.
- Chemical "burndown" of green vegetation after fall plowing/discing prior to final seed bed preparation.
- Uniform flood depth of 3 to 4inches.

Water-seeded rice fields treated with *Bolero* 15 G Herbicide post-flood should be inspected regularly during tillering. If the following symptoms (associated with decomposition of crop/weed residues) occur: 1. dark green foliage, and/or 2. reduced plant height, and/or 3. plant deformation, immediately drain the field (if recirculating systems or water impoundment allows) for 7 to 14 days or until the soil starts to crack. Low spots which do not drain completely may continue to display symptoms.

## SUGGESTED MANAGEMENT PRACTICES POST-FLOOD WATER SEEDED USES OF BOLERO 15 G HERBICIDE

*Bolero* 15 G Herbicide use in rice fields which develop anaerobic (low oxygen content) soil conditions following planting may reduce plant stand and yield. Anaerobic soil conditions are likely to occur when: (1) green matter and crop residue is plowed or worked into the soil prior to planting, (2) internal soil drainage is slow (poor percolation), (3) there is a continuous flood, and (4) there are areas in the field which retain water during periods of prescribed flood removal.

Management practices which will help to minimize the development of anaerobic soil conditions and thereby promote good soil conditions for the production of healthy rice treated with *Bolero* 15 G Herbicide are:

- Removal of previous crop and weed residues, or
  - Destruction of previous crop and weed residues by:
  - burning (where state regulations allows)
  - fall and winter plowing

.

- use of chemical "burndown" (glyphosate or paraquat) to prevent vegetation buildup after initial ground preparation (fall and winter plowing) and prior to final seedbed preparation.
- Application of fertilizer based on soil test results do not apply excess phosphorous.
- Uniform leveling practices which eliminate low spots in the field and ensure that the field can be entirely
  drained, if necessary (This is far more difficult to achieve with the use of contour levees. Fields which have
  been precision leveled for perimeter ditches or straight levees are more suited to rapid removal of flood
  water.)
- Uniform flood depth of 3 to 4 inches.
- Do NOT exceed labeled rates of *Bolero* 15 G Herbicide. Accurately calibrate application equipment and minimize or eliminate application overlap.
- Do NOT use Bolero 15 G Herbicide on water seeded rice grown in fields which have been land leveled resulting in severe cuts and heavily filled areas (does not apply to normal maintenance leveling) in the past 18 months. Fields with a "loose" seedbed may also exhibit severe injury.
- Do NOT use Bolero 15 G Herbicide on rice grown in fields which have received chicken litter or had large
  amounts of green vegetative residue incorporated in the past 10 months.
- Do NOT use Bolero 15 G Herbicide on rice fields which cannot be drained as necessary due to water holding restrictions, should phytotoxic symptoms occur.

 If a post flood *Bolero* 15 G Herbicide program is used in water seeded rice, DO NOT PLANT ADAIR, MILLIE OR L-201 RICE VARIETIES.

Water seeded rice fields treated with *Bolero* 15 G Herbicide (post flood) should be inspected regularly through the stand establishment and tillering stages. If phytotoxic symptoms (see Special Instructions above) occur, immediately drain the field (if recirculating systems or water impoundment allows or the fields is hydrologically isolated) for 7 to 14 days or until the soil starts to crack to allow the soil to oxygenate; then reflood. Low spots which do not drain completely may continue to display phytotoxic symptoms.
