Iris Borer hatch in the spring after 2 consecutive days of 70° weather or above. Apply Iris Guard just before temperatures reach 70°.

New Plantings. (Late Summer-Early Fall)
Spray rhizomes thoroughly on all surfaces.
Allow to dry well on soil to be prepared for planting. Prepare soil as directed for iris. Spray prepared soil with a heavy mist. Plant iris and spray soil and rhizome for about 6" around each planting.

Established Plants. (Spring and fall)
Spray ONLY After Sunset or on Cloudy Days
(This will prevent sunspotting of leaves)

Spray all surfaces of leaves, exposed rhizomes and ground around each plant with a heavy mist. Spray soil between rows or bedding areas.

Reapply if the weather has been cold and growth is retarded or if there has been a series of drizzling rains and growth spurts.

New Growth must be protected.

New research indicates that iris borers can hatch throughout the growing season. To protect your iris, spray in the spring, mid-summer and at the time of transplanting. Spray the tubers well when replanting and spray the ground into which the new tubers are set.
