ULTRIA is a liquid plant growth regulator containing 1-triacontanol. Use it to increase Brix/Acid ratio in oranges and to hasten maturity, enabling earlier harvests.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**REENTRY STATEMENT**

Do not enter treated areas without protective clothing until spray has dried. Because certain states may require more restrictive reentry intervals for various crops treated with this product, consult your State Department of Agriculture for further information.

Written or oral warnings must be given to workers who are expected to be in a treated area or in an area about to be treated with this product. Oral warnings must contain the following information:

Inform workers of areas or fields that must not be entered without appropriate protective clothing until spray has dried. Inform workers that in the event of accidental exposure, all exposed skin should be washed with soap and water and that, if irritation persists after washing, to get medical attention.

**USE ONLY AS DIRECTED.** Good spray techniques should be followed. All instructions should be read thoroughly and understood before use.

Each bottle of ULTRIA is designed for a single application. Once opened, the contents of the bottle should be diluted as soon as possible and any remaining ULTRIA should be diluted within 3 hours.

Discard any unused spray material at the end of each day. **DO NOT STORE OVERNIGHT. DO NOT USE LEFTOVER SOLUTIONS.**

Prepare solution at recommended concentration listed below. Dilute with water only in a clean spray tank.

Only one foliar application is recommended per growing season.

For best results, apply during warmer parts of the day. **DO NOT** apply ULTRIA when air temperature is below 55 degrees F.

Spray thoroughly. All fruit and leaves must be covered with recommended concentration to achieve desired results. Droplet size is not important as long as thorough coverage is obtained.

**DO NOT USE PLASTIC HOSES OR TUBING**, such as polyvinyl chloride (PVC). Use of such material will reduce the effectiveness of ULTRIA. Use rubber hoses if possible.

**DO NOT MIX ULTRIA** with any other compound. Do not mix with herbicides, other pesticides or fertilizer. Do not add a surfactant.

Rainfall within six hours after spraying may reduce the activity of ULTRIA.

**DO NOT SPRAY WITHIN TWO WEEKS OF HARVEST.**

### APPLICATIONS AND SPRAY GUIDELINES

To increase Brix/Acid ratio in oranges and to hasten maturity, enabling earlier harvest.

Dilute entire contents of ULTRIA container (3.4 fluid ounces (100 grams)) in 250 gallons of water. Make one application, as a foliar spray, 3 to 8 weeks before harvest. Apply 5 to 6 gallons per tree for mature trees. Assuming 125 trees per acre, approximately 625 to 750 gallons of ULTRIA solution will be required to treat one acre.

FOR BEST RESULTS on Hamlin, Pineapple and Valencia oranges, dilute entire ULTRIA container (3.4 fluid ounces (100 grams)) in 250 gallons of water. Apply 3 to 6 weeks before harvest.

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store at room temperature. DO NOT FREEZE. Store in original container. Do not remove cap until time of application.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL: PLASTIC CONTAINERS:** Triple rinse (or equivalent).
