### **DANGER/PELIGRO**



#### POISON

Fatal if swallowed or absorbed through skin. May be fatal if inhaled. Do not breathe spray mist. Causes moderate eye irritation. Do not get in eyes, on skin or on clothing. Remove contaminated clothing and wash before reuse. Exposure to this product during pregnancy should be avoided.

Repeated exposures to small amounts of this product can produce accumulative toxicity. Persons at risk should have their prothrombin times checked periodically.

NOTE TO PHYSICIAN OR VETERINARIAN: Contains bromadiolone, an anticoagulant. For humans or dogs that have ingested this product, or have obvious poisoning symptoms (bleeding) or lowered prothrombin times, give Vitamin K, by intramuscular or oral administration. Check prothrombin time every 3 days or until values return to normal.

#### Personal Protective Equipment (PPE) required for this product:

Persons handling this product must use a closed system designed to provide complete dermal and inhalation protection. The system must be capable of removing the pesticide from the original container and transferring it into mixing tanks and/or other equipment used to produce the bait formulations. At any disconnect point, the system must be equipped with a dry disconnect or dry couple shutoff device that is warranted by the manufacturer to minimize drippage to not more than 2 milliliter per disconnect point.

Persons handling this product while using the closed systems must wear:

- long-sleeve shirt and long pants,
- shoes plus socks,
- chemical-resistant gloves,
- 4. chemical-resistant apron, and
- 5. face-sealing goggles.

In case of an emergency spill, a breakdown in the closed system, or other situation where this opened product is not enclosed in a closed system, persons handling or in the immediate area of this product must wear:

- 6. coveralls worn over short-sleeve shirt or short pants,
- chemical-resistant apron,
- 8. socks plus chemical-resistant shoe coverings or chemical-resistant footwear,
- 9. chemical-resistant gloves, and
- 10. NIOSH-approved powered air-purifying respirator (PAPR) equipped with an organic-vapor-removing cartridge and a dust/mist prefilter.
- 11. If PAPR is not available then a NIOSH approved respirator with an organic vapor (OV) cartridge or canister with any R, P, or HE prefilter (if oil not present, an additional prefilter type, N, can be used).
- 12. Face-sealing goggles if PAPR is not used.

Note: It is recommended that you have your respirator fit tested.

#### USER SAFETY REQUIREMENTS

Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

#### **USER SAFETY RECOMMENDATIONS**

Wash thoroughly with soap and water after handling. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.

Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.
