Examples of outdoor sites are: outdoor restaurants, golf courses, parks, cemeteries, amusement parks, backyards, sports complexes, wooded areas, airports, train and/or bus terminals, garden centers, nurseries, farms, mining operations, oilfield and gas exploration operations, tire recycling facilities, landfills, ships, ports, junkyards, power plants and zoos.

How the Mosquito Trap Works: MCSI Mosquito Trap is a trap that kills *Aedes* spp. mosquito larvae, thereby preventing emergence of adult container-breeding *Aedes* mosquitoes that may transmit Zika, dengue, or chikungunya virus to humans. *Aedes* spp. mosquitoes prefer to lay their eggs inside containers or in low-lying areas. When containers or low-lying areas are flooded by water, the eggs hatch and mosquitoes develop. Other mosquito species tend to favor areas that have standing water present most of the time and are not controlled by this product.

A small amount of pesticide is slowly released from the trap liner into the water to kill mosquito larvae hatching from eggs laid inside the trap. The larvicide pyriproxyfen, which is released into the water when the trap is filled with water, kills larvae that hatch from the eggs. The trap can be filled by rainwater entering the trap or it can be filled with freshwater as needed if rainfall is not sufficient.

Mosquito Trap Application and Use:

Preparation:

- Remove mosquito trap from box. Do not use if damaged.
- Fill mosquito trap with water until full to the top.

Placement:

- Place the mosquito trap in an upright position (red cap on top) in areas inaccessible to children or hang from tree or other structure in an outdoor shady area protected from prevailing wind. Avoid sunny areas when possible.

- It is recommended that traps be placed at least 30 feet apart.

Checking and Use:

- Check trap once per week and refill with water as necessary, especially during dry weather.
- Trap requires water to be effective.
- Trap must remain in an upright position to be effective. If trap falls over, return to upright position and refill.
- Begin trap use early in the year after the last frost date and until the first frost late in the year for up to 35 days.
- If trap is damaged, empty water from the trap and discard. Replace trap.
- May be used as an optional method for an Integrated Pest Management (IPM) approach to mosquito control.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Storage: Store unopened container in a cool, dry place until ready for use. Do not store with food.

Pesticide Disposal: Wastes resulting from the use of this product must be disposed on site or at an approved waste disposal facility.

Container Handling: Non-refillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling, if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
