BACK PANEL, Spray: DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

FOR INDOOR USE ONLY

One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectionable odor or sticky mess and, used as directed, does not stain furnishings.

FLEAS AND TICKS: SHAKE WELL. Hold can 2 or 3 feet from surface to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture.
