EPA Registration Number 64240-7
Your submission dated December 11, 1995

This amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable, provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. Add the following precautions to item 2 under Directions. "Do not use in small enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller, instead allow fog to enter from other rooms.". Delete the statement beginning "Use additional units for remote rooms or where free flow of mist is not assured."

3. Submit three (3) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

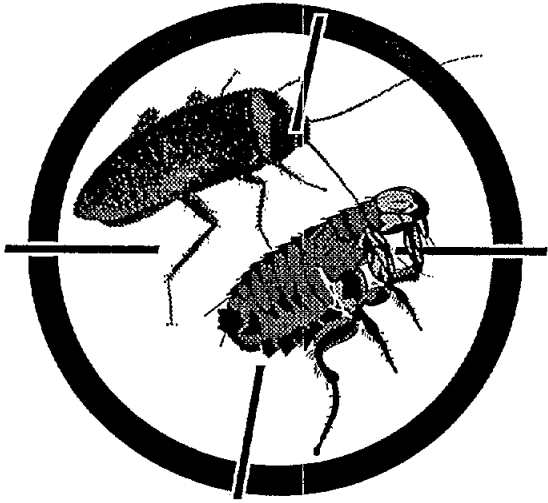

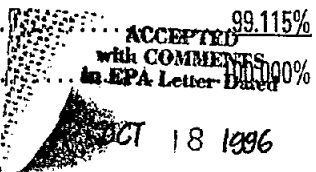

1. Cover exposed food, dishes, and food-handling equipment. Open cabinets and doors to area[s] to be treated. Shut off fans and air conditioners. **PUT OUT ALL FLAMES AND [SHUT OFF] PILOT LIGHTS.** Close exterior doors and windows. 25 X 25
2. Point valve opening away from face and eyes when releasing. [Use one unit for each 5,000 cubic feet of unobstructed area.] -or- Use only one can for rooms 20' X 30' (with an 8' ceiling) or smaller. Do not use in cabinets or other small areas. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry. X
3. **TO OPERATE VALVE:** To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. [Then] place fogger on stand or table or floor in the center of the room with valve locked open, placing -or- with several layers of newspaper or pad -or- paper towel under fogger. 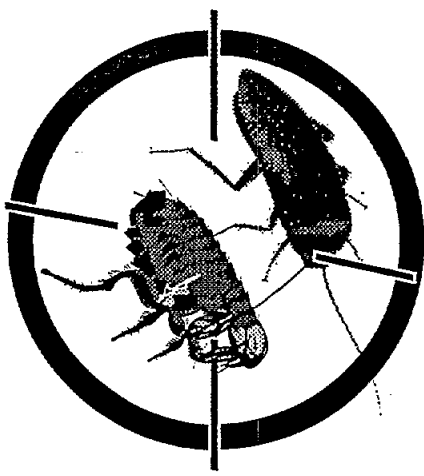

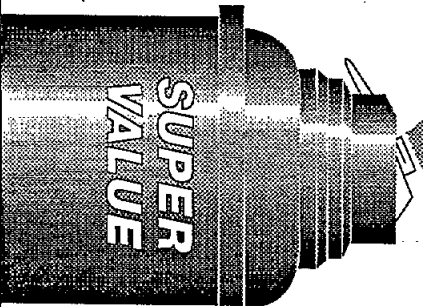
