#### **DIRECTIONS FOR USE**

Wear gloves when using the product and wash hands thoroughly after handling.

1. For general control of ants outdoors around your home, garage or any other building.

(Directions for use for the bottle with measuring cap)

Pour granules into the bottle cap to the 1/2 oz. fill line. Lightly apply one cap (1/2oz) of granules every 10 feet around the perimeter of your home. Sprinkle granules sparingly so that they are barely visible.

(Directions for use for the tip and measure dosing bottle)

Turn the container upside-down to fill 1/2 oz. of granules into the doser. Apply granules from the doser around the perimeter of your home using one dose (1/2 oz) per 10 feet. Sprinkle granules sparingly so that they are barely visible.

One container is sufficient to treat an average sized home. For best results, apply granules in shaded areas (i.e. under overhangs, next to foundations).

2. For localized activity such as ant hills, mounds, and/or trails, fill the (cap/doser) to 1 oz. and apply granules around each ant hill, mound, or trail. For best results, do not put the granules directly in or on the mound. **Do not disturb the mound.** This will aggravate the ants and cause them to move their mound.

3. After application, you may see increased ant activity around COMBAT granules. **Do not spray or interfere with their feeding.** The ants need time to take the granules back to the colony to destroy the queen and the entire colony.
4. You should expect to see a significant reduction in ants within a week.
5. Repeat treatment after one week if infestation persists or if large colonies are involved.
6. For best results, apply late in the day when ants are more active. Avoid outdoor application if rain threatens.
