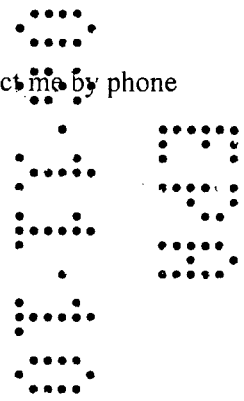

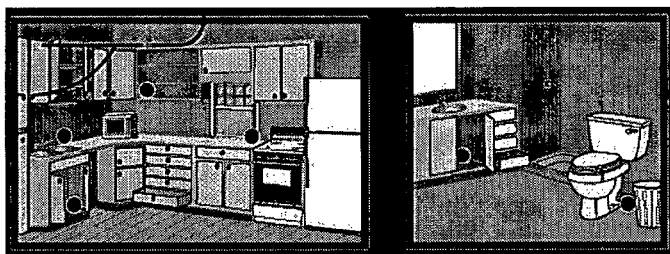

2. For best results, use all 8 [or 12] bait stations at one time.
3. Place at least 6 - or -10 bait stations in the kitchen and 1 - or - 2 in each bathroom [food storage and water sources are the most common roach areas.] Specific placement areas include under appliances and sinks, on floor along baseboards, near pet food storage and inside cabinets and drawers.
