The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

- 1. The Agency has determined that all references to kill and/or control claims exceeding 3 months must be qualified by stating "up to" prior to the portrayal of efficacy duration on the label. Therefore, claims that exceed 3 months such as "kills for 1-6 months" should read "kills for up to 1-6 months". Additionally, a label advisory should be added to the label to qualify the variables affecting the success of the cockroach bait applications. The Agency is recommending the following advisory: "The success of Combat Small Roach Bait F.03 to kill/control small cockroaches can be affected by cockroach population size, sanitary conditions, and the extent to which other residents apply cockroach control methods." Any other advisory depicted on the label will negate the provisions by which this product labeling is conditionally approved.
- 2, Remove "Long term control in just 3 days [guaranteed] for <u>1-6</u> months" and "Controls in 3 days for <u>1-6</u> months" from the labeling.
- 3. Either delete the following claims or have them qualified by adding a respective claim of duration such as "for up to 6 months".
 - a) non-stop roach control

- b) works day after day -or- works day and night
- c) kills over night and keeps on killing
- d) kills roaches 24 hours a day, 7 days a week
- 4) Delete the claim "the clean way to kill roaches", and "...destroys (kills)(roaches) by contact" from the labeling.



- 1. Remove wrapper. Break baits apart. Do not remove or puncture the label on bait station. Now the baits are ready to use. For best results use all 12 baits [at one time.]
- 2. Place baits wherever you see or have seen roaches -or- signs of roaches -or where roaches are found. Then place additional baits about 11/2 feet away. [Some of the most likely locations -or- hiding places for roaches are shown in the diagram to the right. TIP: For best results, place baits about 1¹/2 feet away from each other.]
- 3. Put out all 12 baits. If you have fewer than 12 places where you have seen roaches, place the extra baits about 1 1/2 feet away from the other baits that you have just placed. Roaches find the bait faster when all bait stations -or- baits are placed out.


