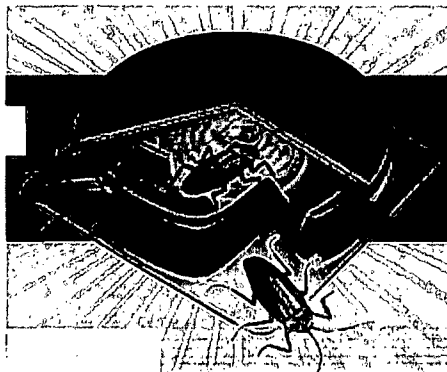

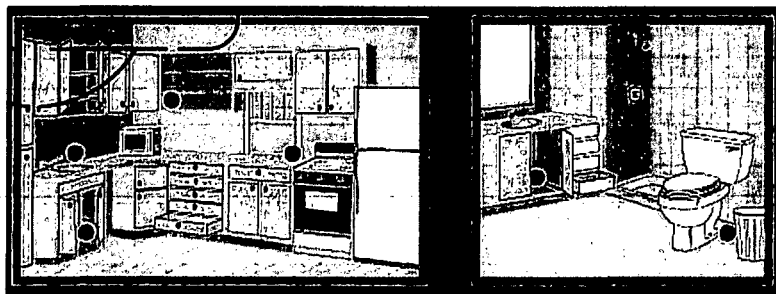

Then place additional baits about 1½ feet away.
