Amendment to add claims against large cockroaches.

Dear Ms. Anastasiou:

The above referenced submission in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3(c)(7)(a), is acceptable subject to the following comments and/or terms for conditionally accepted amendment.

The requested added claims for American cockroaches (large cockroaches) are acceptable for this
product, provided that the stations allow for full access of large cockroaches to the fipronil
treated bait.

Provide the Agency with evidence that the entry hole on this bait station is of adequate size to allow entry by the larger American cockroaches — either by sending a sample station to the Agency or providing a scaled picture for evaluation by the efficacy team/RM reviewer.

Modify the claims "overnight [action] formula" and "kills overnight" to read "starts killing overnight", "starts working overnight", "starts working as soon as cockroaches feed on bait" or similar wordings that provide a more accurate representation of how the product works.

These claims imply 24 hour efficacy, but the bait product does not work within 1 day. Generally, baits are not fast acting and should not be marketed as something that would eliminate a cockroach infestation "overnight".

Please note that we have approved the amendment for the subject product with the understanding that the labeling is consistent with the Agency's previously approved labels and with the labels for other identical products. Your failure to comply with the above stated conditions nullifies our conditional acceptance of the proposed labeling amendment.

Enclosed with this letter, see our review (dated April 05, 2010) of your submitted Efficacy data, and revise the labeling accordingly to reflect the comments stated in the DER. Submit final printed label to the Agency prior to releasing this product for shipment. See enclosed stamped label for your record. 



- 1. [Remove wrapper.] [U]use all [2] [4] [6] [8] [12] [18] [24] [30] baits [at one time] [at the same time]. Break baits apart. Do not remove or puncture [the] label[s] on bait station[s]. [Now the baits are ready to use.]
- 2. Place baits wherever [you see or have seen [roaches] [signs of roaches]] [where roaches are found] [in the following places: under appliances and sinks, on floor along baseboards, near pet food storage and inside cabinets and drawers.]

 Then place additional baits about 1½ feet away. [Put any remaining baits as shown in the diagram[s] to the [right] [[left] [above] [below.] [Some of the most likely [locations for roaches] [roach hiding places] are shown in the diagram[s] to the [right] [left] [above] [below].
