To prevent misuse, statements about where to place bait stations must be qualified as follows: "wherever you see or have seen roaches in the following places:[list specific placement areas]", "wherever roaches have been found in the following places: [list specific placement areas]".

The cited product provided a calendar to replace bait stations every 3/6 months. Similarly, revise the label to provide a calendar in the directions for use to replace bait stations every 3/6 months.
