

- c. The term, Microorganisms, is too broad since your product only mitigates viruses and bacteria. Therefore, delete the 16th bullet and term in the 40th bullet on page 5.
- H1N1 claims are not acceptable because they are not in agreement with Agency policy (http://www.epa.gov/oppad001/h1n1-guide.html). Therefore, you must delete the 25th claim on page 5.
- e. According to the efficacy review, disinfectant against viruses since data was not conducted in organic soil. Therefore, you must delete all references as a One Step Cleaner Disinfectant:
 - Revise "to clean and disinfect" heading on page 3 to read "to i. disinfect."
 - Delete the 8th, 11th, 30th, 31st, and 34th claims on page 5.


