The product referred to above will be acceptable for registration under FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling changes listed below:

a. Replace the Statement of Practical Treatment section with "IF SWALLOWED: Call a physician or Poison Control Center. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists. IF IN EYES: Hold eyelids open and flush with steady, gentle stream of water for 15 minutes. Get medical attention. NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. May pose an aspiration pneumonia hazard."
