- b. Delete the term "Only" in the statement below the product's name to read "For Manufacturing Use." You may insert the term "Intended" to have it read: "Intended for Manufacturing Use." The Agency cannot enforce that this will be for manufacturing purposes only.
- c. Based on the toxicity classification, reorganize the First Aid statements to the following order:

"If in Eyes,..."

"If on Skin or Clothing,..."

"If Swallowed,..."

"If Inhaled...."

d. List appropriate PPE in the Precautionary Statements by adding the following statement:

"Wear safety goggles or face shield, protective clothing, and chemical resistance gloves."

- e. Delete the fifth sentence of the Precautionary Statements.
- f. As per the Copper Naphthenate RED, Revise the first sentence of the Environmental Hazards to read:

"This pesticide is toxic to aquatic invertebrates, shrimp, and oysters/clams."

- g. Delete the term "only" in the second to last sentence of the Directions for Use to read "Exterior Use" or "Intended for Exterior Use" for the same reason in bullet b.
- h. As per the signal word, "Danger," the Pesticide Disposal statements must be revised to read:

"Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance."
